

Identification of services provided by the voluntary organisations for people living with neurological conditions in the community in each CHO region.







#### We need your input

- We know that the services that you provide are vital in supporting people living with neurological conditions.
- It is important that your work is captured and recognised.

- Discussion Points for Friday 22nd April
- 1. Feedback on Service Descriptors:
- Finalising the list of services and the overarching categories
- 2. Survey Design (including anything we change based on the focus groups/interviews)
- Crowe may have a clear understanding of survey design but we need to understand it as Project Partners including:
- -duplication of the same service descriptor under multiple categories (based on how this went down with the focus groups)
- -an "other" option under each category
- -how a single key contact in each organisation collates responses for each CHO (for example do they get a pdf of survey so they can circulate within their org to collate organisation-wide info in advance of data entry)
- 3. Survey Logistics and Timeframes
- -timeframe for survey development/testing/rollout (identifying the key tasks in this and what Project Partners need to do in parallel to support it)
- -feasibility of getting enough orgs on board in this 2 week window
- organising a one off group "briefing session" for the key contacts from each organisation on how to fill out survey (with Crowe participation)
- (NAI/HSE did this in 2018 mapping and found it extremely helpful to troubleshoot and maximise responses)
- -We have key contacts registering via a registration page on and after 20th April but we need to check with Crowe the following
- (i) does this registration page constitute permission from org (ii) data sharing perspective: are we in NAI/DFI in a position to remind/encourage those who have not completed surveys to do so

#### **General queries**

- Queries on Home from Home?
- Query about what home from home services are versus step down care?
- Query on 5.m. Day services accessibility supports. Includes both communication and physical accessibility?
- Where is independence? Result not service. Similarly, community inclusion questioned outcome or service? Part of PCP?
- Does there need to be a separate service for acquired RT and Day Services?? No pot though so not funded service
- What about Family support service or Community Resource that includes both family and individual?? Would end up ticking under 9. And any of the other 9 categories that the individual avails of. Agreed that that was ok.
- Advocacy on national policy issues raised and agreed that as it wasn't a direct service it was ok to exclude.
- Conversation about including definitions for categories and agreed that better to

category.

- Questions around the inclusion of a glossary of terms, like the HSE one, e.g. indicating what are day services i.e. day services might be 'new directions' fundec day services
- Query if survey queries will be directed to a dedicated person?
- Discussion around drop down boxes for notes being available on the survey?
- Queries research and PPI (patient participation involvement) at the universities. Noted that this is a type of service because it offers the facility for 'patient voice' i.e. research with a patient rather than on a patient
- Query about what is meant by a specialist nurse specifically i.e. what kinds of specialist nursing?
