# OIREACHTAS DISABILITY GROUP PRE BUDGET 2020 ASKS

#### Introduction

The Oireachtas Disability Group, ODG is a cross-party/non-party group of Dáil Deputies, Senators and representatives from the disability sector. The United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) enshrines the civil, political, social, economic and cultural rights of persons with disabilities. It does not create any new rights, rather formulates existing rights in a disability compliant prism. Ratification of the UNCRPD means that there is a legally binding international instrument to guarantee, for the first time ever, that the State must promote and protect the rights of people with disabilities. Ratification on its own will not change the lives of people with disabilities, unless this is underpinned by the joined up thinking and resource allocation across all government departments.

Funding is required to enable the implementation of UNCRPD and of Government policies related to services for people with disabilities. Government must assess

the funding requirements and implications of a systemic implementation of UNCRPD across all Government departments and public bodies, and for all disability service providers. This was part of the Oireachtas Disability Group, ODG's Budget 2019 document and remains a priority. Too often, policy is developed without funding being allocated to the transition or ongoing costs of policy implementation, related service reconfiguration and the delivery of individualised services to which Government is committed. The list below outlines some of the policy areas where lack of funding has already resulted in delayed implementation of policy.

In relation to UNCRPD provisions, e.g. housing (Article 19), transport (Article 20) and Assistive Technology (various articles), there is a real and urgent need to provide adequate funding to enable people with disabilities access housing, transport and education or work.

## **Department actions**

Set out below are the departmental and inter-departmental actions needed to address a wide range of barriers faced by people with disabilities, from disability services to transportation and employment. They are a reminder that every part of government, not just the Department of Health, must be involved in the goal of full equality.

Many of the actions identified below are also reflected in the National Disability Inclusion Strategy, NDIS. These actions should be complemented by the Departmental Statements of Strategy and the Public Sector Duty which oblige state departments to consider the impact of their work on the human rights and equality of anyone impacted by their programmes of work.

#### Conclusion

The Articles of UN CRPD are interconnected. In order to realise one right, the others must also be realised, and vice versa. The actions outlined here for each department similarly complements actions by other Departments. While one Department may take the lead on delivering an action under the NDIS and UN CRPD, collaboration from the outset of planning services across departments is required in order to be effective. The Department of the Taoiseach should lead, coordinate and ensure that there is effective progress across all Departments and Public Bodies. (Article 33 UNCRPD/ Disability Miscellaneous Provisions Bill 2016). There is a need to provide a single focal point for monitoring the UNCRPD based within the Department of An Taoiseach. This would represent a commitment to persons with disabilities and ensure that the UNCRPD is given a cross-departmental focus.
